This Release is given to the "Released Entities" which include the NJSC, all officers and directors, all committee persons, trip leaders, and all representatives and members of the NJSC.

I agree that I will release the "Released Entities" from any and all responsibility of liability for injuries or damages to me or to any other person. I agree NOT to make a claim or sue any of the "Released Entities" for damages relating to skiing, snow boarding (snow sports), travel to and from the ski area, and other included activities on this trip, whether it arises from NEGLIGENCE or any other liability arising of the "Released Entities". In the event that a claim is made by or on behalf of me against the "Released Entities," I agree to indemnify and hold harmless the "Released Entities" for any and all losses, including damages, interest and all costs of defense, including attorney fees and other costs.
